

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Schuk Toak District - Santa Rosa Ranch Community
Budget Amendment No. 1)

RESOLUTION NO. 18-031

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2018 Schuk Toak District Budget in the amount of \$6,416,946.22 which
13 included the FY 2018 Santa Rosa Ranch Community Budget, was approved by
14 Tohono O'odham Legislative Council Resolution No. 17-429; and

15 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-01-13-18-002, the Schuk Toak
16 District has authorized and submitted for review and approval its Schuk Toak
17 District - Santa Rosa Ranch Community Budget Amendment No. 1, which is
18 incorporated by this reference; and

19 **WHEREAS,** the Schuk Toak District - Santa Rosa Ranch Community Budget Amendment No.
20 1 will decrease and increase in operational line items but will not alter the
21 overall FY 2018 Santa Rosa Ranch Community Budget amount of \$214,525.81 or
22 the FY 2018 Schuk Toak District Budget of \$6,416,946.22; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Schuk Toak
24 District - Santa Rosa Ranch Community Budget Amendment No. 1 and
25 recommends its approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 FY 2018 Schuk Toak District - Santa Rosa Ranch Community Budget Amendment
28 No. 1, which does not alter the overall FY 2018 Schuk Toak District Budget of
29 \$6,416,946.22.

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2018 Schuk
31 Toak District - Santa Rosa Ranch Community Budget Amendment No. 1 shall be
32 managed and expended in accordance with Article IX, Section 7 of the
33 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that
34 any amendments or modifications shall be authorized under District Council

resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH day of JANUARY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;-0- AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
