

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham Nation
for the month of February 2018)

RESOLUTION NO. 18-034

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests**
2 **the Tohono O'odham Legislative Council with the power to "enact laws and**
3 **ordinances governing the enrollment and adoption of members and the**
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance,**
6 **Ordinance No. 05-81 as amended the Enrollment Committee has received**
7 **written statements from 2 tribal members who have expressed their intent to**
8 **relinquish their membership with the Tohono O'odham Nation and the**
9 **members are identified in the February 2018 Relinquishment List, which is**
10 **incorporated by this reference; and**

11 **WHEREAS, pursuant to Article IX Section 1 of the Enrollment Ordinance,**

12 **A member of the Nation may relinquish his membership in the Nation by**
13 **submitting a written statement clearly expressing an intent to relinquish**
14 **his membership to the Council, a copy of which must be served on the**
15 **committee. The written statement must be signed by the person wishing**
16 **to relinquish his membership or, if a minor or incompetent, by the**
17 **parent(s), guardian or other person legally authorized to act on his**
18 **behalf. Relinquishment does not require the approval of the Council, but**
19 **is effective upon receipt of the statement by the Council and cannot be**
20 **subsequently denied. Upon recognition by the Council that the**
21 **individual has renounced his membership, his name shall be deleted**
22 **from the membership roll.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
24 **recognizes that the individuals identified in the February 2018 Relinquishment**
25 **List have relinquished their membership in the Tohono O'odham Nation and**
26 **orders the removal of their names from the Nation's membership roll.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
28 **day of FEBRUARY, 2018 at a meeting at which a quorum was present with a vote of 2,821.0 FOR;**
29 **263.6 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council**
30 **by Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**




