

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Department of Public Safety Environmental Protection Office  
Clean Air Act Program Budget Amendment No. 1)**

**RESOLUTION NO. 18-040**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "all**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the FY 2018 Department of Public Safety Environmental Protection Office Clean**  
8 **Air Act Budget in the amount of \$205,300.00 was approved by Resolution No. 17-**  
9 **466; and**

10 **WHEREAS, the Department of Public Safety Environmental Protection Office has prepared**  
11 **and submitted for review and approval its FY 2018 Clean Air Act Program Budget**  
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**  
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2018 Department of Public Safety Environmental Protection Office Clean**  
15 **Air Act Program Budget Amendment No. 1 will decrease the Department of Public**  
16 **Safety Environmental Protection Office FY 2018 Clean Air Act Program Budget by**  
17 **\$122,300.00 from \$205,300.00 to \$83,000.00; and**

18 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**  
19 **2018 Department of Public Safety Environmental Protection Office Clean Air Act**  
20 **Program Budget Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2018 Department of Public Safety Environmental Protection Office Clean Air**  
23 **Act Program Budget Amendment No. 1 which includes a \$122,300.00 decrease**  
24 **from \$205,300.00 to \$83,000.00, and which shall be funded by the U.S.**  
25 **Environmental Protection Agency Assistant Agreement Grant pursuant to Section**  
26 **103 of the Clean Air Act.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
28 **Nation Chairperson or any designated official is authorized to administer and**  
29 **expend the FY 2018 Department of Public Safety Environmental Protection Office**  
30 **Clean Air Act Program Budget as amended, provided however, that any**  
31 **amendments or modifications shall be submitted for prior approval by the**  
32 **Tohono O'odham Legislative Council.**





7 18, 1934 (48 Stat.984).


