

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2018 Office of the Prosecutor Tohono O'odham Victim**  
**Witness Program Budget)**

**RESOLUTION NO. 18-050**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the U.S. Department of Justice, Office for Victims of Crime awarded the Tohono**  
8 **O'odham Nation Office of the Prosecutor Grant Award No. 2016-VR-GX-K008 in**  
9 **the amount of \$450,000.00 for a three year period beginning October 1, 2016 and**  
10 **ending September 30, 2019; and**

11 **WHEREAS, Grant Award No. 2016-VR-GX-K008 was accepted by Resolution No. 17-136; and**

12 **WHEREAS, the Office of the Prosecutor has prepared and submitted for review and**  
13 **approval its FY 2018 Tohono O'odham Victim Witness Program Budget, which is**  
14 **incorporated by this reference, in the amount of \$203,956.61; and**

15 **WHEREAS, this budget does not include Indirect Cost ("IDC") as the agency will not allow**  
16 **IDC to be charged without a current year IDC agreement; and**

17 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees have reviewed the**  
18 **FY 2018 Office of the Prosecutor Tohono O'odham Victim Witness Program**  
19 **Budget and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2018 Office of the Prosecutor Tohono O'odham Victim Witness Program**  
22 **Budget effective October 1, 2017, in the amount of \$203,956.61 that shall be**  
23 **funded by the Nation's general fund pending reimbursement by the grantor.**

24 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council waives the IDC for the**  
25 **FY 2018 Office of the Prosecutor Tohono O'odham Victim Witness Program**  
26 **Budget.**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
28 **Tohono O'odham Nation Chairperson or any designated official to seek**  
29 **reimbursement or recoup any IDC expense in the event an IDC rate is**  
30 **subsequently approved by the Interior Business Center.**


31 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
32 **O'odham Nation chairperson or any designated official is authorized to**  
33 **administer and expend the FY 2018 Office of the Prosecutor Tohono O'odham**  
34 **Victim Witness Program Budget, provided however, that any amendments or**




