

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Education Child Care and Development
Fund - Discretionary Budget Amendment No. 1)

RESOLUTION NO. 18-051

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Education Child Care and Development Fund -**
8 **Discretionary Budget in the amount of \$641,517.00 was approved by Resolution**
9 **No. 17-450; and**

10 **WHEREAS, the Department of Education Child Care Services has prepared and submitted**
11 **for review and approval its FY 2018 Child Care and Development Fund -**
12 **Discretionary Budget Amendment No. 1, which is incorporated by this reference**
13 **and which will adjust operational and/or personnel line items; and**

14 **WHEREAS, the FY 2018 Department of Education Child Care and Development Fund -**
15 **Discretionary Budget Amendment No. 1 will increase the Department of**
16 **Education FY 2018 Child Care and Development Fund - Discretionary Budget by**
17 **\$36,556.00 from \$641,517.00 to \$678,073.00; and**

18 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
19 **reviewed the FY 2018 Department of Education Child Care and Development**
20 **Fund - Discretionary Budget Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2018 Department of Education Child Care and Development Fund -**
23 **Discretionary Budget Amendment No. 1 effective October 1, 2017, which**
24 **includes a \$36,556.00 increase from \$641,517.00 to \$678,073.00 that shall be**
25 **funded by the Nation's general fund pending reimbursement from the grantor.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
27 **O'odham Nation chairperson or any designated official is authorized to**
28 **administer and expend the FY 2018 Department of Education Child Care and**
29 **Development Fund - Discretionary Budget as amended, provided however, that**
30 **any amendments or modifications shall be submitted for prior approval by the**
31 **Tohono O'odham Legislative Council.**
