

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Detention Services Agreement between Maricopa County on  
behalf of the Maricopa County Sheriff's Office and the Tohono O'odham Nation)**

**RESOLUTION NO. 18-053**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**  
2 **negotiate and conclude agreements and contracts on behalf of the Tohono**  
3 **O'odham Nation ("Nation") with Federal, State, and local governments."**  
4 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)); and**

5 **WHEREAS, the Nation provides 24 hour police services to the West Valley Casino located at**  
6 **9431 W. Northern Ave, Glendale, AZ 85305 and desire to contract with the**  
7 **Maricopa County on behalf of the Maricopa County Sheriff's Office to provide**  
8 **detention services for the Nation's Police Department servicing the West Valley**  
9 **Casino; and**

10 **WHEREAS, the Maricopa County on behalf of the Maricopa County Sheriff's Office will**  
11 **supply safekeeping, care and maintenance of persons arrested by the Nation**  
12 **and booked into the Maricopa County's detention system at a rate of \$325.65 per**  
13 **inmate booked; \$101.72 per inmate per day; \$100.00 per day for Psychological**  
14 **Housing if needed; and**

15 **WHEREAS, the Nation shall provide the minimum required insurance for Commercial**  
16 **General Liability, Automobile Liability and Workers Compensation Insurance**  
17 **provided in Attachment A; and**

18 **WHEREAS, the fees accrued, will be paid by FY 2018 Department of Public Safety, West**  
19 **Valley Resort professional services line item; and**

20 **WHEREAS, the Domestic Affairs Committee of the Legislative Council have reviewed this**  
21 **Intergovernmental Agreement and recommends its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
23 **approves the Detention Services Agreement by and between Maricopa County on**  
24 **behalf of the Maricopa County Sheriff's Office and the Tohono O'odham Nation**  
25 **for purpose of providing detention services for the Nation's Police Department**  
26 **servicing the West Valley Casino substantially in the form attached hereto.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
28 **the Nation's Chairperson and any designated official to enter into this**  
29 **agreement, provided that any amendments affecting the funds or funding level**  
30 **shall be submitted for further prior approval by the Tohono O'odham Legislative**  
31 **Council.**


