## **LEGISLATIVE ORDER NO. 18-054**

WHEREAS,	the Constitution of the Tohono O'odham Nation empowers the Legislative
	Council to "enact laws and ordinances for conducting and regulating elections"
	and provides that the "decision of the Tohono O'odham Council in all election
	matters, including the eligibility and qualifications of candidates, shall be final"
	(Constitution, Article VI, Section 1(g) and Article X, Section 7); and
WHEREAS,	the Legislative Council alternate seat to Sells District Representative Arthur
	Wilson is vacant; and
WHEREAS,	pursuant to 12 T.O.C. Chapter 1, Section 1505(B)(3), when a Legislative Council
	alternate's seat is vacant, a district may "adopt a resolution appointing an
	alternate who shall hold office for the unexpired term of his predecessor;
	provided that the alternate shall not be seated until the Board certifies in
	writing that the alternate meets all the qualifications for that office"; and
WHEREAS,	on December 21, 2017 the Sells District Council appointed Evelyn Juan-Manuel
	to serve as alternate to Legislative Representative Arthur Wilson on the
	Legislative Council (Sells District Resolution No. SD-86-17); and
WHEREAS,	by letter dated February 8, 2018, the Election Board has certified in writing that
	Evelyn Juan-Manuel meets all the qualifications for the office of Legislative
	Council alternate.
NOW, THERE	FORE, BE IT ORDERED that the Tohono O'odham Legislative Council recognizes
	the Sells District Council appointment of Evelyn Juan-Manuel to serve as
	alternate to Legislative Representative Arthur Wilson and seats alternate Evelyn
	Juan-Manuel, who shall serve in accordance with the Constitution and laws of
	the Tohono O'odham Nation and with the rules and procedures of the Legislative
	Council when Representative Arthur Wilson is unable to attend a Legislative
	Council session.
