

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 426-86, 12-88, and 66-89 to Reflect Legal  
Name Changes of Enrolled Members)**

**RESOLUTION NO. 18-062**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**  
11 **O'odham Legislative Council shall determine whether an application is**  
12 **approved for membership and its determination, along with the resolution**  
13 **number and date of enactment, shall be provided to the applicant; and**

14 **WHEREAS, the Enrollment Program has received the official documents showing the legal**  
15 **name changes of enrolled members due to a variety of reasons, such as**  
16 **marriage, divorce, or legal adoption; and**

17 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 426-86, 12-**  
18 **88, and 66-89 be amended to reflect the amended names for the members**  
19 **identified in the March 2018 Amended Enrollment Resolution Summary, which**  
20 **is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**  
22 **that Resolution Nos. 426-86, 12-88, and 66-89 are amended upon the effective**  
23 **date of those resolutions to reflect the legal name changes for the members**  
24 **identified in the March 2018 Amended Enrollment Resolution Summary.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
26 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
29 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
30 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
31 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
