

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Department of Health and Human Services, Division of  
Behavioral Health Tas Tonlik Ki Program Budget Amendment No. 1)**

**RESOLUTION NO. 18-067**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Department of Health and Human Services, Division of Behavioral  
8 Health Tas Tonlik Ki Program Budget in the amount of \$1,250,438.00 was  
9 approved by Resolution No. 17-447; and

10 **WHEREAS,** the Department of Health and Human Services, Division of Behavioral Health has  
11 prepared and submitted for review and approval its FY 2018 Tas Tonlik Ki  
12 Program Budget Amendment No. 1, which is incorporated by this reference, and  
13 which adjusts personnel and/or operational line items, including addition of an  
14 Administrative Assistant position; and

15 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
16 reviewed the FY 2018 Department of Health and Human Services, Division of  
17 Behavioral Health Tas Tonlik Ki Program Budget Amendment No. 1 and  
18 recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2018 Department of Health and Human Services, Division of Behavioral Health  
21 Tas Tonlik Ki Program Budget Amendment No. 1 effective October 1, 2017 in the  
22 amount of \$1,250,438.00 which shall be funded by program revenues.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
24 Nation chairperson or any designated official is authorized to administer and  
25 expend the FY 2018 Department of Health and Human Services, Division of  
26 Behavioral Health Tas Tonlik Ki Program Budget Amendment No. 1, provided that  
27 any amendments or modifications shall be submitted for prior approval by the  
28 Tohono O'odham Legislative Council.

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
30 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
31 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
32 **Article VI, Sections 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat.984).**


