

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2018 Department of Health and Human Services, Senior Services**  
**Division Budget Amendment No. 1)**

**RESOLUTION NO. 18-069**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Health and Human Services, Senior Services Division**  
8 **Budget in the amount of \$682,324.02 was approved by Resolution No. 17-437; and**

9 **WHEREAS, the Department of Health and Human Services, Senior Services Division has**  
10 **prepared and submitted for review and approval its FY 2018 Budget Amendment**  
11 **No. 1, which is incorporated by this reference and which will adjust operational**  
12 **and/or personnel line items due to allocation reductions in grant awards; and**

13 **WHEREAS, the FY 2018 Department of Health and Human Services, Senior Services Division**  
14 **Budget Amendment No. 1 will not increase the total budget amount; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
16 **reviewed the FY 2018 Department of Health and Human Services, Senior Services**  
17 **Division Budget Amendment No. 1 and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2018 Department of Health and Human Services, Senior Services Division**  
20 **Budget Amendment No.1 effective October 1, 2017 in the amount of \$682,324.02**  
21 **that shall be funded by the Nation's general fund.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
23 **Nation chairperson or any designated official is authorized to administer and**  
24 **expend the FY 2018 Department of Health and Human Services, Senior Services**  
25 **Division Budget as amended, provided however, that any amendments or**  
26 **modifications shall be submitted for prior approval by the Tohono O'odham**  
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
29 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Sections 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**
