

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Chukut Kuk District West Villages Community
Budget Amendment No. 1)**

RESOLUTION NO. 18-070

1 **WHEREAS, Pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No District shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation and all expenditure of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the District Council**

11 **; and**

12 **WHEREAS, by Chukut Kuk District Resolution No. 2017-48, the FY 2018 Chukut Kuk District**
13 **Budget in the amount of \$1,976,701.13 was authorized by Chukut Kuk District**
14 **Council and approved by Legislative Council Resolution No. 17-420; and**

15 **WHEREAS, by Chukut Kuk District Council Resolution No. 2018-05, the West Villages**
16 **Community has authorized and submitted for review and approval its FY 2018**
17 **Budget Amendment No. 1, which is incorporated by this reference and which will**
18 **adjust operational and/or personnel line items; and**

19 **WHEREAS, the Chukut Kuk District West Villages Community Budget Amendment No. 1 will**
20 **increase the West Villages Community Budget by \$24,850.02 from \$40,000 to**
21 **\$64,850.02; and**

22 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2018 Chukut Kuk District**
23 **West Villages Community Budget Amendment No. 1 and recommends its**
24 **approval.**

25 **NOW, THEREFORE BE, IT RESOLVED that the Tohono O'odham Legislative Council**
26 **approves the FY 2018 Chukut Kuk District West Villages Community Budget**
27 **Amendment No. 1, which includes a \$24,850.02 increase from \$40,000 to**
28 **\$64,850.02.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2018 Chukut**
30 **Kuk District West Villages Community Budget as amended shall be managed and**
31 **expended in accordance with Article IX, Section 7 of the Constitution of the**
32 **Tohono O'odham Nation and the Nation's laws, provided that any amendments or**
