

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Sells District Budget Amendment No. 1)

RESOLUTION NO. 18-074

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council

11 ; and

12 **WHEREAS,** the FY 2018 Sells District Budget in the amount of \$3,044,855.16 was authorized by
13 Sells District Council Resolution No. SD-56-17 and approved by Legislative
14 Council Resolution No. 17-425; and

15 **WHEREAS,** by Sells District Council Resolution No. SD-04-18, the Sells District Council has
16 authorized and submitted for review and approval its FY 2018 Sells District
17 Budget Amendment No. 1, which is incorporated by this reference and which will
18 adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2018 Sells District Budget Amendment No. 1 will not increase or decrease
20 the total budget amount; and

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Sells District Budget
22 Amendment No. 1 and recommends its approval.


23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 FY 2018 Sells District Budget Amendment No. 1, which does not change the overall
25 total budget amount.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2018 Sells
27 District Budget as amended shall be managed and expended in accordance with
28 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the
29 Nation's laws, provided that any amendments or modifications shall be
30 authorized under District Council resolution and submitted for prior approval by
31 the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


