

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Sells District Cowlic Community INT-01-14 Budget)

RESOLUTION NO. 18-078

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council

11 ; and

12 **WHEREAS,** by Sells District Council Resolution No. SD-08-18, the Sells District has authorized
13 the FY 2018 Sells District Cowlic Community INT-01-14 Budget, which is
14 incorporated by this reference, in the amount of \$23,261.32; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Sells District Cowlic
16 Community INT-01-14 Budget and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2018 Sells District Cowlic Community INT-01-14 Budget in the amount of
19 \$23,261.32.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2018 Sells
21 District Cowlic Community INT-01-14 Budget shall be managed and expended in
22 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
23 Nation and the Nation's laws, provided that any amendments or modifications
24 shall be authorized under District Council resolution and submitted for prior
25 approval by the Tohono O'odham Legislative Council.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
27 day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-
28 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
29 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
30 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
31 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
