

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an FY 2018 Attorney Contract with Richards Brandt Miller Nelson)**

**RESOLUTION NO. 18-082**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**  
2 **the power to "employ legal counsel for the protection and advancement of the**  
3 **rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**  
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General requires the legal services of law firm Richards**  
6 **Brandt Miller Nelson to provide legal advice and representation to the Tohono**  
7 **O'odham Nation's Office of Attorney General in matters relating to a Child**  
8 **Welfare case in the State of Utah; and**

9 **WHEREAS, fees for services under this contract will be paid by the Tohono O'odham Nation's**  
10 **Office of Attorney General operating budget under the line item 7355 -**  
11 **Professional Services; and**

12 **WHEREAS, the Domestic Affairs Committee has reviewed the FY 2018 Attorney Contract with**  
13 **Richards Brandt Miller Nelson and recommends its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves**  
15 **the Attorney Contract for FY 2018 with Richards Brandt Miller Nelson and**  
16 **authorizes the chairperson of the Tohono O'odham Nation to execute it in**  
17 **substantially the form attached.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>**  
19 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 2(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**  
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat.984).**




