

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Sells District Sells Community Budget Amendment No. 1 and  
FY 2018 Sells District Administration Budget Amendment No. 2)**

**RESOLUTION NO. 18-083**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 **Nation,**

3           **No district council shall expend district funds except pursuant to**  
4 **budgets authorized under resolutions of the district council and**  
5 **approved by the Tohono O'odham Council. The management of these**  
6 **funds shall be only by a treasurer or other authorized officer of the**  
7 **district council who has furnished a surety bond satisfactory to the**  
8 **treasurer of the Tohono O'odham Nation, and all expenditures of these**  
9 **funds shall be by checks signed by such treasurer or other authorized**  
10 **officer and the chairman or vice chairman of the district council**

11           **; and**

12 **WHEREAS,** the FY 2018 Sells District Budget in the amount of \$3,044,855.16 was authorized  
13 **by Sells District Council Resolution No. SD-56-17 and approved by Legislative**  
14 **Council Resolution No. 17-425; and**

15 **WHEREAS,** by Sells District Council Resolution No. SD-17-18 and SD-21-18, the Sells District  
16 **Council has authorized and submitted for review and approval its FY 2018 Sells**  
17 **District Sells Community Budget Amendment No. 1 and Sells District**  
18 **Administration Budget Amendment No. 2, which is incorporated by this**  
19 **reference and which will adjust operational line items; and**

20 **WHEREAS,** the FY 2018 Sells District Sells Community Budget Amendment No. 1 and Sells  
21 **District Administration Budget Amendment No. 2 will not increase or decrease**  
22 **the total overall budget amount of \$3,044,855.16; and**

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Sells District Sells  
24 **Community Budget Amendment No. 1 and FY 2018 Sells District Administration**  
25 **Budget Amendment No. 2 and recommends their approval.**

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
27 **FY 2018 Sells District Sells Community Budget Amendment No. 1 and FY 2018**  
28 **Sells District Administration Budget Amendment No. 2, which does not change**  
29 **the overall total budget amount of \$3,044,855.16.**

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2018 Sells  
31 **District Sells Community Budget and FY 2018 Sells District Administration**  
32 **Budget as amended shall be managed and expended in accordance with Article**  
33 **IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's**  
34 **laws, provided that any amendments or modifications shall be authorized**
