

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Department of Health and Human Services Division of  
Senior Services Vehicles Budget)**

**RESOLUTION NO. 18-086**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Division of Senior Services has prepared and submitted a tribal**  
8 **supplemental one-time funding request to purchase two 14 passenger Arboc**  
9 **Spirit of Mobility 26 Buses and four 15 passenger Ford Transit Wagons for review**  
10 **and approval in the amount of \$342,717.20, which is incorporated by this**  
11 **reference; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
13 **reviewed the FY 2018 Department of Health and Human Services Division of**  
14 **Senior Services Vehicles Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
16 **FY 2018 Department of Health and Human Services Division of Senior Services**  
17 **Vehicles Budget effective October 1, 2017 in the amount of \$342,717.20 that shall**  
18 **be funded by the Tohono O'odham Nation's general fund surplus.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
20 **O'odham Nation Chairperson or any designated official is authorized to**  
21 **administer and expend the FY 2018 Department of Health and Human Services**  
22 **Division of Senior Services Vehicles Budget, provided however, that any**  
23 **amendments or modifications shall be submitted for prior approval by the**  
24 **Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
26 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article VI, Sections 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
31 **June 18, 1934 (48 Stat.984).**
