

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services Komckud Ki:
Domestic Violence Budget)

RESOLUTION NO. 18-087

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services ("DHHS") prepared and submitted**
8 **for review and approval its FY 2018 Komckud Ki: Domestic Violence Budget,**
9 **which is incorporated by this reference, in the amount of \$52,683.06 to be funded**
10 **from (1) a \$42,700.00 donation from the 14th Annual Desert Diamond Casinos Golf**
11 **Classic, and (2) a \$9,983.06 carry forward balance from the FY 2017 DHHS**
12 **Komckud Ki: Domestic Violence Budget, which was approved by Resolution No.**
13 **16-561; and**

14 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
15 **reviewed the FY 2018 DHHS Komckud Ki: Domestic Violence Budget and**
16 **recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2018 DHHS Komckud Ki: Domestic Violence Budget, effective October 1, 2017,**
19 **in the amount of \$52,683.06, which shall be funded by (1) \$42,700.00 donation**
20 **from the 14th Annual Desert Diamond Casinos Golf Classic, and (2) the \$9,983.06**
21 **carry forward balance from the FY 2017 DHHS Komckud Ki: Domestic Violence**
22 **Budget.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Tohono**
24 **O'odham Nation chairperson or any designated official to administer and expend**
25 **the FY 2018 DHHS Komckud Ki: Domestic Violence Budget provided, however,**
26 **that any amendments or modifications shall be submitted to the Tohono**
27 **O'odham Legislative Council for prior approval.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
29 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Sections 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
