

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Chukut Kuk District Budget Amendment No. 1 and FY
2018 Chukut Kuk District Tecolote Community Budget Amendment No. 2)**

RESOLUTION NO. 18-092

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 "No District shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation and all expenditure of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council"

11 ; and

12 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2017-48, the FY 2018 Chukut Kuk
13 District Budget in the amount of \$1,976,701.13 was authorized by the Chukut Kuk
14 District Council and approved by Legislative Council Resolution No. 17-420; and

15 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2018-05 and 2018-06, the Chukut
16 Kuk District Council authorized budget amendments for the West Villages and
17 Tecolote Community, increasing the FY 2018 Chukut Kuk District Budget by
18 \$29,102.02 from \$1,976,701.13 to \$2,005,803.15, which was approved by Legislative
19 Council Resolution No. 18-070; and

20 **WHEREAS,** the Chukut Kuk District, by Chukut Kuk District Council Resolution No. 2018-12,
21 authorized and submitted for review and approval its FY 2018 Tecolote
22 Community Budget Amendment No. 2 which is incorporated by this reference and
23 which will increase operational and/or line items by \$13,067.44 from \$44,252.00
24 to \$57,319.44; and

25 **WHEREAS,** the Chukut Kuk District, by Chukut Kuk District Council Resolution No. 2018-13,
26 authorized and submitted for review and approval its FY 2018 Budget
27 Amendment No. 1 which is incorporated by this reference and which will create a
28 new line item and increase the budget amount by \$71,150 from \$2,005,803.15 to
29 \$2,076,953.15; and

30 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Chukut Kuk District
31 Tecolote Community Budget Amendment No. 2 and the FY 2018 Chukut Kuk
32 District Budget Amendment No. 1 and recommends its approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the:

- (1) FY 2018 Chukut Kuk District Tecolote Community Budget Amendment No. 2, which includes a \$13,067.44 increase from \$44,252.00 to \$57,319.44; and**
- (2) Chukut Kuk District Budget Amendment No. 1, which includes a \$71,150.00 increase from \$2,005,803.15 to \$2,076,953.15, increasing the overall budget by \$84,217.44 from \$2,005,803.15 to \$2,090,020.59.**

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2018 Chukut Kuk District Tecolote Community Budget and the FY 2018 Chukut Kuk District Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
