

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Senior Services Title VI Part A Budget and Title VI Part C Budget)

RESOLUTION NO. 18-094

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services Division of Senior Services has**
8 **prepared and submitted its FY 2019 Title VI Part A Budget in the amount of**
9 **\$180,720.00 and Title VI Part C Budget in the amount of \$55,280.00, which are**
10 **incorporated by this reference and funded by the Nation's general fund pending**
11 **reimbursement by grantor, Title VI of the Older Americans Act of 1978; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2019 Department of Health and Human Services Division of**
14 **Senior Services Title VI Part A Budget and Title VI Part C Budget and recommend**
15 **their approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2019 Department of Health and Human Services Division of Senior Services**
18 **Title VI Part A Budget in the amount of \$180,720.00 and Title VI Part C Budget in**
19 **the amount of \$55,280.00 for a period beginning April 1, 2018 to March 31, 2019,**
20 **which shall be funded by the Nation's general fund pending reimbursement**
21 **from the grantor, Title VI Older Americans Act of 1978.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
23 **O'odham Nation chairperson or any designated official is authorized to**
24 **administer and expend the FY 2019 Department of Health and Human Services**
25 **Division of Senior Services Title VI Part A Budget and Title VI Part C Budget,**
26 **provided that any amendments or modifications shall be submitted for prior**
27 **approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
29 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
34 **June 18, 1934 (48 Stat.984).**
