

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Professional Services Agreement between the
Tohono O'odham Nation and Garden House, Inc.)**

RESOLUTION NO. 18-096

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to consult, negotiate and**
2 **conclude agreements and contracts on behalf of the Tohono O'odham Nation**
3 **with Federal, State and local governments and other Indian tribes or their**
4 **departments, agencies, or political subdivisions, or with private persons or**
5 **organizations on all matters within the authority of the Tohono O'odham**
6 **Council." (Constitution, Article VI, Section 1 (f)); and**

7 **WHEREAS, Amendment No. 1 to the Professional Services Agreement between the Tohono**
8 **O'odham Nation ("Nation") and Garden House, Inc. ("Garden House"), which is**
9 **incorporated by this reference, will allow Garden House to provide residential**
10 **and foster care services for the Nation's Children In Need of Care for the period**
11 **of October 1, 2017 to September 30, 2018; and**

12 **WHEREAS, Amendment No. 1 to the Professional Services Agreement between the Nation**
13 **and Garden House ("the Agreement") has been reviewed by the Office of Attorney**
14 **General as required by law; and**

15 **WHEREAS, the FY 2018 Department of Health and Human Services Division of Child Welfare**
16 **Tribal Child Welfare Budget 001-18-6051 will fund this Agreement; and**

17 **WHEREAS, the Health and Human Services Committee has reviewed the Agreement and**
18 **recommends approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
20 **Amendment No. 1 to the Professional Services Agreement between the Tohono**
21 **O'odham Nation and Garden House, Inc. in substantially the form attached and**
22 **authorizes the Tohono O'odham Nation chairperson to execute and administer**
23 **the Agreement.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
25 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(c)(2), 1(d)(3), 1(f) of the Constitution of the Tohono O'odham Nation,**
28 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
30 **16 of the Act of June 18, 1934 (48 Stat.984).**
