RESOLUTION NO. 18-100

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
11 **O'odham Legislative Council shall determine whether an application is**
12 **approved for membership and its determination, along with the resolution**
13 **number and date of enactment, shall be provided to the applicant; and**

14 **WHEREAS, the Enrollment Program has received the official documents showing the legal**
15 **name changes of enrolled members due to a variety of reasons, such as**
16 **marriage, divorce, or legal adoption; and**

17 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 32-80, 15-**
18 **82, 141-90, 91-368, 94-154, 95-415, 2000-397, 02-180, 03-280, 10-153, and 17-488 be**
19 **amended to reflect the amended names for the members identified in the April**
20 **2018 Amended Enrollment Resolution Summary, which is incorporated by this**
21 **reference.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**
23 **that Resolution Nos. 32-80, 15-82, 141-90, 91-368, 94-154, 95-415, 2000-397, 02-**
24 **180, 03-280, 10-153, and 17-488 are amended upon the effective date of those**
25 **resolutions to reflect the legal name changes for the members identified in the**
26 **April 2018 Amended Enrollment Resolution Summary.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
28 **day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
30 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
31 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
32 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
33 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
