

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Certification of and Distribution to A Tohono O'odham Nation Eligible
Adult Member for the Initial Per Capita Distribution for April 2018)

RESOLUTION NO. 18-105

1 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the
2 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes
3 per capita payments to the Nation's members provided that sufficient gaming
4 revenues are available; and

5 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities Within the Tohono
6 O'odham Nation (the "Gaming Ordinance") was subsequently amended to
7 authorize per capita distribution payments in accordance with the Initiative
8 (Legislative Council Resolution No. 97-303); and

9 **WHEREAS,** pursuant to Resolution No. 97-451 the Tohono O'odham Legislative Council
10 adopted an Initiative Funding and Implementation Plan; and

11 **WHEREAS,** the Legislative Council did adopt the Revenue Allocation Plan pursuant to
12 Legislative Council Resolution No. 97-452; and

13 **WHEREAS,** by letter dated December 18, 1997, the Area Office of the Bureau of Indian Affairs
14 approved the Initial Per Capita Distribution; and

15 **WHEREAS,** the Tohono O'odham Nation Enrollment Office submitted to the Tohono
16 O'odham Legislative Council the Certification of Eligible Members for the Initial
17 Per Capita Distribution for review and approval; and

18 **WHEREAS,** Legislative Council approved the Certification of Eligible Members, with the
19 initial number of 11,233 verified adult members (Resolution Number 97-525);
20 and

21 **WHEREAS,** the disbursement of funds to each eligible adult member is contingent upon
22 verification of a member and certification by the Tohono O'odham Legislative
23 Council; and

24 **WHEREAS,** the Tohono O'odham Department of Membership Services has submitted a
25 certification listing of one verified adult member who is listed on the previously
26 approved Certification of Eligible Members and is eligible to receive the initial
27 per capita payment.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby:

- 29 1. Approves the verification and certification of the adult member listed on
30 the attached April 2018 Certification Listing of An Adult Member for the
31 Initial Per Capita Distribution.
- 32 2. Approves the distribution for \$2,000, less any applicable taxes required
33 by federal law, to the adult member listed.

1 3. Authorizes the Chairperson of the Nation or a designated official to
2 execute such other documents as may be necessary to implement this
3 resolution.

4 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of
5 funds to additional eligible Tohono O'odham adult members is contingent upon
6 verification of membership by the Tohono O'odham Department of Membership
7 Services and certification by the Tohono O'odham Legislative Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH
9 day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-
10 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
11 Article VI, Sections 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
12 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
13 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
14 June 18, 1934 (48 Stat.984).
