

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an FY 2018 Attorney Contract with the Law Firm of Dentons US LLP)**

RESOLUTION NO. 18-107

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power to "employ legal counsel for the protection and advancement of**
3 **the rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of**
6 **Dentons US LLP to represent the Tohono O'odham Nation in matters relating to**
7 **the Nation's West Valley Reservation and its use for gaming-related economic**
8 **development, the completion of the West Valley Reservation fee-to-trust**
9 **acquisition, and other matters as assigned for the period of October 1, 2017 to**
10 **September 30, 2018; and**


11 **WHEREAS, fees for services under this contract will be paid by the Tohono O'odham Gaming**
12 **Enterprise budget; and**

13 **WHEREAS, the Domestic Affairs and Commerce Committees has reviewed the FY 2018**
14 **attorney contract with the law firm of Dentons US LLP and recommends**
15 **approval by the Legislative Council.**

16 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves**
17 **the FY 2018 attorney contract with the law firm of Dentons US LLP and**
18 **authorizes the chairperson of the Tohono O'odham Nation to execute it in**
19 **substantially the form attached.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
21 **day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
26 **June 18, 1934 (48 Stat.984).**
