

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Public Safety Personnel Retirement System Refund  
Budget Amendment No. 1)**

**RESOLUTION NO. 18-113**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Refund Public Safety Personnel Retirement System Refund Budget in  
8 the amount of \$930,731.67 was approved by Resolution No. 17-480; and

9 **WHEREAS,** the Executive Office received a letter from the Public Safety Personnel  
10 Retirement System specifying the post-judgment interest calculation due to  
11 current and former public safety personnel amounts to \$157,889.01; and

12 **WHEREAS,** the Executive Office has prepared and submitted for review and approval the FY  
13 2018 Public Safety Personnel Retirement System Refund Budget Amendment No.  
14 1, which is incorporated by this reference and which will adjust personnel line  
15 items; and

16 **WHEREAS,** the FY 2018 Public Safety Personnel Retirement System Refund Budget  
17 Amendment No. 1 will increase the FY 2018 Public Safety Personnel Retirement  
18 System Refund Budget Amendment by \$157,889.01 from \$930,731.67 to  
19 \$1,088,630.68 to pay interest due to current and former public safety personnel;  
20 and

21 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY  
22 2018 Public Safety Personnel Retirement System Refund Budget Amendment No.  
23 1 and recommend its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
25 FY 2018 Public Safety Personnel Retirement System Refund Budget Amendment  
26 No. 1 effective October 1, 2017, which includes a \$157,889.01 increase from  
27 \$930,731.67 to \$1,088,630.68 that shall be funded by the Nation's general fund  
28 surplus.

29 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the payroll  
30 supervisor and treasurer shall report the status of refunds including post-  
31 judgment interest in writing on a monthly basis to the Budget and Finance and  
32 Domestic Affairs Committees.

33 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
34 Nation chairperson or any designated official is authorized to administer and  
35 expend the FY 2018 Public Safety Personnel Retirement System Refund Budget as

1 amended exclusively to award refunds to eligible participants, provided however,  
2 that any amendments or modifications shall be submitted for prior approval by  
3 the Tohono O'odham Legislative Council.

4 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>  
5 day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-  
6 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
7 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
8 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
9 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
10 18, 1934 (48 Stat.984).
