

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2018 Department of Education Vocational Rehabilitation**  
**Program Budget Amendment No. 1)**

**RESOLUTION NO. 18-114**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Department of Education Vocational Rehabilitation Program Budget  
8 in the amount of \$450,723.00 was approved by Resolution No. 17-453; and

9 **WHEREAS,** the Department of Education Vocational Rehabilitation Program has prepared  
10 and submitted for review and approval its FY 2018 Vocational Rehabilitation  
11 Program Budget Amendment No. 1, which is incorporated by this reference and  
12 which will adjust operational and/or personnel line items; and

13 **WHEREAS,** the FY 2018 Department of Education Vocational Rehabilitation Program Budget  
14 Amendment No. 1 will not increase the overall budgeted amount of \$450,723.00;  
15 and

16 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
17 reviewed the FY 2018 Department of Education Vocational Rehabilitation  
18 Program Budget Amendment No. 1 and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2018 Department of Education Vocational Rehabilitation Program Budget  
21 Amendment No. 1, which will adjust operational and/or personnel line items with  
22 no increase to the overall budgeted amount of \$450,723.00.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
24 Nation chairperson or any designated official is authorized to administer and  
25 expend the FY 2018 Department of Education Vocational Rehabilitation Program  
26 Budget as amended, provided however, that any amendments or modifications  
27 shall be submitted for prior approval by the Tohono O'odham Legislative Council.

28 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>  
29 day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-  
30 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
31 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
32 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
33 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
34 18, 1934 (48 Stat.984).




