

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Hewel Ni'ok Capital Projects Budget)**

RESOLUTION NO. 18-117

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2018**
8 **Hewel Ni'ok Capital Projects Budget, which is incorporated by this reference, in**
9 **the amount of \$71,605.50 to be funded from the Nation's general fund surplus;**
10 **and**


11 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**
12 **FY 2018 Hewel Ni'ok Capital Projects Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **FY 2018 Hewel Ni'ok Capital Projects Budget effective October 1, 2017 in the**
15 **amount of \$71,605.50, which shall be funded by the Nation's general fund surplus.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
17 **Nation chairperson or any designated official is authorized to administer and**
18 **expend the FY 2018 Hewel Ni'ok Capital Projects Budget, provided that any**
19 **amendments or modifications shall be submitted for prior approval by the**
20 **Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
22 **day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
25 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat.984).**
