

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Natural Resources Rodeo Queen Budget Amendment No. 1)

RESOLUTION NO. 18-129

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "all**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Natural Resources Rodeo Queen Budget in the amount**
8 **of \$49,933.72 was approved by Resolution No. 17-437; and**

9 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
10 **approval its FY 2018 Rodeo Queen Budget Amendment No. 1, which is**
11 **incorporated by this reference and which will adjust operational line items; and**

12 **WHEREAS, the FY 2018 Department of Natural Resources Rodeo Queen Budget Amendment**
13 **No. 1 will not change the budget total; and**

14 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
15 **have reviewed the FY 2018 Department of Natural Resources Rodeo Queen Budget**
16 **Amendment No. 1 and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2018 Department of Natural Resources Rodeo Queen Budget Amendment No.**
19 **1, which will not change the budget total of \$49,933.72.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2018 Department of Natural Resources Rodeo Queen Budget as**
23 **amended, provided however, that any amendments or modifications shall be**
24 **submitted for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
26 **day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**






