

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Intergovernmental Personnel Act Agreement and Extension of
Intergovernmental Personnel Act Agreement Templates between Indian
Health Service and the Tohono O'odham Nation)**

RESOLUTION NO. 18-131

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "to consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**
5 **or with private persons or organizations on all matters within the authority of the**
6 **Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and**

7 **WHEREAS, the Tohono O'odham Nation ("Nation") negotiated and implement a self-**
8 **governance compact with the Indian Health Service for the operation Tohono**
9 **O'odham Nation Health Care ("TONHC"); and**

10 **WHEREAS, in accordance with Resolution No. 16-075, the Nation, in order to operate TONHC**
11 **programs, functions, services and activities, entered into Intergovernmental**
12 **Personnel Act agreements in accordance with P.L. 93-638, Section 104(B) for IHS**
13 **employees; and**

14 **WHEREAS, the Nation desires to enter into new Intergovernmental Personnel Act**
15 **agreements and extend prior Intergovernmental Personnel Act agreements with**
16 **IHS employees; and**

17 **WHEREAS, the Health and Human Services Committee of the Legislative Council has**
18 **reviewed the Intergovernmental Personnel Act Agreement model template and**
19 **the Extension of Intergovernmental Personnel Act Agreement model template**
20 **and recommends their approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **Intergovernmental Personnel Act Agreement model template and the Extension**
23 **of Intergovernmental Personnel Act Agreement model template, substantially in**
24 **the form attached, and authorizes the Chairperson of the Nation to enter into and**
25 **sign agreements with IHS, IHS employees, and the Nation, and to take any other**
26 **action required to carry out the intent of this resolution.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
28 **day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**






