

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Department of Public Safety 638 Corrections Program  
Budget Amendment No. 1)**

**RESOLUTION NO. 18-137**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Public Safety 638 Corrections Program Budget in the**  
8 **amount of \$4,434,648.32 was approved by Resolution No. 17-438; and**

9 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**  
10 **approval its FY 2018 638 Corrections Program Budget Amendment No. 1, which is**  
11 **incorporated by this reference, and which adds carryover savings from FY 2017**  
12 **and increases line items and adds new line items; and**

13 **WHEREAS, this increase changes the Indirect Cost charges; and**

14 **WHEREAS, the FY 2018 Department of Public Safety 638 Corrections Program Budget**  
15 **Amendment No. 1 will increase the FY 2018 Department of Public Safety 638**  
16 **Corrections Program Budget by \$1,687,413.93 from \$4,434,648.32 to**  
17 **\$6,122,062.25; and**

18 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**  
19 **2018 Department of Public Safety 638 Corrections Program Budget Amendment**  
20 **No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2018 Department of Public Safety 638 Corrections Budget Amendment No. 1**  
23 **effective October 1, 2017, which includes a \$1,687,413.93 increase from**  
24 **\$4,434,648.32 to \$6,122,062.25 that shall be funded by the FY 2017 638 Corrections**  
25 **Program Budget carryover savings.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
27 **Nation chairperson or any designated official is authorized to administer and**  
28 **expend the FY 2018 Department of Public Safety 638 Corrections Program Budget**  
29 **as amended, provided however, that any amendments or modifications shall be**  
30 **submitted for prior approval by the Tohono O'odham Legislative Council.**
