

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Legislative Branch Budget Amendment No. 1 and Legislative
Attorney's Office Career Ladder)**

RESOLUTION NO. 18-139

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Legislative Branch Budget in the amount of \$3,500,211.81 was
8 approved by Resolution No. 17-436; and

9 **WHEREAS,** the Legislative Branch has prepared and submitted for review and approval its FY
10 2018 Budget Amendment No. 1, which is incorporated by this reference and which
11 will adjust operational and/or personnel line items; and

12 **WHEREAS,** the FY 2018 Legislative Branch Budget Amendment No. 1 includes a proposal to
13 establish a Legislative Attorney's Office Career Ladder, which is incorporated by
14 this reference, that would create one additional assistant legislative attorney
15 position and adopt a career ladder applicable to assistant legislative attorneys
16 that employs the same compensation structure as the Office of the Attorney
17 General assistant attorney general career ladder that the Legislative Council
18 approved by Resolution No. 08-242; and

19 **WHEREAS,** the FY 2018 Legislative Branch Budget Amendment No. 1 will increase the
20 Legislative Branch FY 2018 Budget by \$371,647.05 from \$3,500,211.81 to
21 \$3,871,858.86; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Legislative Branch
23 Budget Amendment No. 1 and Legislative Attorney's Office Career Ladder and
24 recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 FY 2018 Legislative Branch Budget Amendment No. 1 which includes a
27 \$371,647.05 increase from \$3,500,211.81 to \$3,871,858.86 that shall be funded by
28 the General Fund.

29 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council approves the
30 Legislative Attorney's Office Career Ladder, which shall become effective and be
31 implemented upon the effective date of this resolution, and which shall be
32 amended by further Legislative Council resolution when necessary.

1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
2 Legislative Council chairperson or any designated official is authorized to
3 administer and expend the FY 2018 Legislative Branch Budget as amended,
4 provided that any modifications shall be submitted to the Budget and Finance
5 Committee for approval on behalf of the Legislative Council and amendments
6 shall be submitted for prior approval by the Tohono O'odham Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH
8 day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 2,749.0 FOR 335.6
9 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
10 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
11 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
13 18, 1934 (48 Stat.984).
