

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 17-471 "Approving FY 2018 Tohono O'odham**  
**Nation Health Care Budgets")**

**RESOLUTION NO. 18-140**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation Health Care ("TONHC") Governing Body, subject to  
8 the review and approval by oversight committees and Legislative Council, was  
9 delegated the authority to review and approve all TONHC budgets and budgets  
10 expending health self-governance funds, including budgets expending such  
11 funds for supporting programs with other Nation's departments (Tohono  
12 O'odham Nation Health Care Governing Body Bylaws, Section 9403 (A)); and

13 **WHEREAS,** the Department of Health and Human Services, Department of Public Safety-  
14 Health Care Center Security, Department of Information and Technology, Facility  
15 Management Program, and Planning and Economic Development Department  
16 prepared and submitted for review and approval the FY 2018 Tohono O'odham  
17 Nation Health Care Budgets for the period beginning October 1, 2017 and ending  
18 on September 30, 2018; and

19 **WHEREAS,** by Resolution No. 17-471, the Tohono O'odham Legislative Council approved the  
20 FY 2018 Tohono O'odham Nation Health Care Budget in the amount of  
21 \$113,047,335.94; and

22 **WHEREAS,** while Resolution No. 17-471 approved the correct total budget amount of  
23 \$113,047,335.94 for the FY 2018 Tohono O'odham Nation Health Care Budgets, the  
24 amounts listed in Resolution No. 17-471 for each department's budget did not  
25 include indirect costs, which were included in each program budget; and

26 **WHEREAS,** it is necessary to correct this typographical error for the following amounts to  
27 reflect the actual budgets approved by Resolution No. 17-471:

29 Department of Public Safety-Health Care Center Security	\$1,028,808.07

2 **Legislative Council have reviewed this resolution and recommend approval.**


3 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends the**  
4 **third whereas clause of Resolution No. 17-471 for the following amounts,**  
5 **provided that nothing in this resolution amends the FY 2018 Tohono O'odham**  
6 **Nation Health Care Budgets or the total budget amount of \$113,047,335.94**  
7 **effective October 1, 2017:**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
14 **Nation chairperson or any designated official is authorized to administer and**  
15 **expend the FY 2018 Tohono O'odham Nation Health Care Budgets, provided that**  
16 **any amendments or modifications shall be submitted for prior approval by the**  
17 **Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
19 **day of APRIL, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
21 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
22 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat.984).**
