2		within the exclusive control of the Tohono O'odham Nation and to appropriate
3		these funds for the benefit of the nation and its members" provided that "[a]]]
4		expenditures of these funds shall be pursuant to appropriations or budgets'
5		authorized by resolution or ordinance (Constitution of the Tohono O'odham
6		Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS,	the Tohono O'odham Nation Health Care ("TONHC") Governing Body, subject to
8		the review and approval by oversight committees and Legislative Council, was
9		delegated the authority to review and approve all TONHC budgets and budgets
10		expending health self-governance funds, including budgets expending such
11		funds for supporting programs with other Nation's departments (Tohono
12		O'odham Nation Health Care Governing Body Bylaws, Section 9403 (A)); and
13	WHEREAS,	the Tohono O'odham Nation Health Care prepared and submitted for review and
14	:	approval the FY 2018 Tohono O'odham Nation Health Care Start Up Budget for the
15		period beginning October 1, 2017 and ending on September 30, 2018 and
16	<u>{</u>	incorporated by this reference, in the total amount of \$605,945.14; and
17	WHEREAS,	the Governing Body, pursuant to the Governing Body Bylaws at Article III, Section
18		9401(d) and the CMS conditions of participation found at 42 CFR Part 482(d)(1), is
19		legally responsible for an institutional plan that "must include an annual
20		operating budget that includes all anticipated income and expenses"; and
21	WHEREAS,	the TONHC Governing Body has reviewed the FY 2018 Tohono O'odham Nation
22		Health Care Start Up Budget and recommends approval; and
23	WHEREAS,	the Health and Human Services and Budget and Finance Committees of the
24		Legislative Council have reviewed the FY 2018 Tohono O'odham Nation Health
25		Care Start Up Budget and recommend approval.
26	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
27		FY 2018 Tohono O'odham Nation Health Care Start Up Budget effective October 1,
28		2017 in the total amount of \$605,945.14, which shall be funded by the Indian
29		Health Service.
30	BE IT FINALL	Y RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
31		Nation chairperson or any designated official is authorized to administer and
32		expend the FY 2018 Tohono O'odham Nation Health Care Budgets, provided, that
33		the Governing Body shall approve any amendments or modifications, subject to
34		final approval by the Tohono O'odham Legislative Council.
