

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Overriding Veto of Resolution No. 18-108, "Confirming the Interim Appointment
of Representative Billman Lopez to the Community Development
Financial Institution Board")**

RESOLUTION NO. 18-144

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to "provide for,
2 appoint, or provide for the appointment of, and prescribe the duties and
3 powers of committees, boards, officers and agents" (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(b)); and

5 **WHEREAS,** the Legislative Council has adopted the Charter for the Community Development
6 Financial Institution of the Tohono O'odham Nation ("Charter"), establishing the
7 Community Development Financial Institution ("CDFI") as an enterprise of the
8 Tohono O'odham Nation and the CDFI Board ("Board") (10 Tohono O'odham Code
9 Chapter 2); and

10 **WHEREAS,** on April 9, 2018, the Tohono O'odham Legislative Council passed Resolution No.
11 18-108, "Confirming the Interim Appointment of Representative Billman Lopez to
12 the Community Development Financial Institution Board"; and

13 **WHEREAS,** pursuant to Article VII, Section 5 of the Nation's Constitution,
14 Every law, ordinance, resolution or separate appropriation item passed by the
15 Tohono O'odham Council shall be presented to the chairman for his approval
16 before it becomes effective. If he approves, he shall sign it. But if he disapproves,
17 he shall return it to the Tohono O'odham Council within forty-eight (48) hours,
18 with his objections. If after consideration, it again passes the council by a
19 majority of two-thirds (2/3) of the votes cast, it shall become law and he shall sign
20 it notwithstanding his objections.

22 **WHEREAS,** on April 17, 2018, the Chairman vetoed Resolution No. 18-108; and

23 **WHEREAS,** pursuant to Article IX, Sections 2(B), (C), and (D) of the Legislative Rules of the
24 Tohono O'odham Legislative Council, vetoed legislation shall be placed on the
25 agenda of the next legislative session for reconsideration, shall have priority over
26 all items, and the Chairperson of the Legislative Council, may, without debate,
27 call for a final vote on the vetoed legislation.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council overrides the
29 veto of Resolution No. 18-108, "Confirming the Interim Appointment of
30 Representative Billman Lopez to the Community Development Financial
31 Institution Board."
