

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Hewel Ni'ok CPB CSG Unrestricted Budget Amendment No. 2)**

RESOLUTION NO. 18-150

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, by Resolution No. 17-475, as amended by Resolution No. 17-571, the Legislative**
8 **Council approved the Hewel Ni'ok CPB CSG Unrestricted Budget; and**

9 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2018 CPB**
10 **CSG Unrestricted Budget Amendment No. 2, which is incorporated by this**
11 **reference, in the amount of \$210,234.89 to be funded by FY 2017 Hewel Ni'ok CPB**
12 **CSG Unrestricted Budget carry over funds and CPB CSG grant allocation; and**

13 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have reviewed**
14 **the FY 2018 Hewel Ni'ok CPB CSG Unrestricted Budget Amendment No. 2 and**
15 **recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2018 Hewel Ni'ok CPB CSG Unrestricted Budget Amendment No. 2, effective**
18 **October 1, 2017 in the amount of \$210,234.89 which shall be funded by FY 2017**
19 **Hewel Ni'ok CPB CSG Unrestricted Budget carry over funds and CPB CSG grant**
20 **allocation.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2018 Hewel Ni'ok CPB CSG Unrestricted Budget, provided that any**
24 **amendments or modifications shall be submitted for prior approval by the**
25 **Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
27 **day of MAY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
