

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Executive Branch Office of the Chairman Budget Amendment No. 1)

RESOLUTION NO. 18-162

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Executive Branch Office of the Chairman Budget in the amount of**
8 **\$1,250,689.14 was approved by Resolution No. 17-437; and**

9 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**
10 **2018 Office of the Chairman Budget Amendment No. 1, which is incorporated by**
11 **this reference and which will increase operational line items; and**

12 **WHEREAS, the FY 2018 Executive Branch Office of the Chairman Budget Amendment No. 1**
13 **will increase the FY 2018 Office of the Chairman Budget by \$27,500.00 from**
14 **\$1,250,689.14 to \$1,278,189.14; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2018 Executive Branch**
16 **Office of the Chairman Budget Amendment No. 1 and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2018 Executive Branch Office of the Chairman Budget Amendment No. 1**
19 **effective October 1, 2017, which includes a \$27,500.00 increase from \$1,250,689.14**
20 **to \$1,278,189.14 that shall be funded by Nation's general fund surplus.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2018 Executive Branch Office of the Chairman Budget as amended,**
24 **provided however, that any amendments or modifications shall be submitted for**
25 **prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
27 **day of MAY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
