

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2018 Executive Branch Office of the Chairman Special Projects Budget)**

**RESOLUTION NO. 18-163**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY  
8 2018 Office of the Chairman Special Projects Budget, which is incorporated by  
9 this reference, in the amount of \$148,588.47 to be funded by the Nation's general  
10 fund surplus; and


11 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Executive Branch  
12 Office of the Chairman Special Projects Budget and recommends its approval;  
13 and

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
15 Executive Branch Office of the Chairman Special Projects Budget effective  
16 October 1, 2017 in the amount of \$148,588.47, which shall be funded by the  
17 Nation's general fund surplus.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
19 Nation chairperson or any designated official is authorized to administer and  
20 expend the FY 2018 Executive Branch Office of the Chairman Special Projects  
21 Budget, provided that any amendments or modifications shall be submitted to  
22 the Tohono O'odham Legislative Council for prior approval.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>  
24 day of MAY, 2018 at a meeting at which a quorum was present with a vote of 2,519.15 FOR; 565.45  
25 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
26 Article VI, Section (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the  
27 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
29 18, 1934 (48 Stat.984).
