

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Bureau of Indian Affairs Judicial Service P.L. 93-638 Budget
Amendment No. 1 to include FY 2017 Carry Forward Savings)**

RESOLUTION NO. 18-180

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Bureau of Indian Affairs Budgets under the P.L. 93-638 Master**
8 **Contract in the amount of \$16,807,295.09 was approved by Resolution No.17-438,**
9 **which includes the Judicial Services P.L. 93-638 Budget in the amount of**
10 **\$482,787.93; and**

11 **WHEREAS, the Financial Status Report, which is incorporated by this reference, identifies FY**
12 **2017 P.L. 93-638 carry forward savings in the amount of \$110,770.18; and**

13 **WHEREAS, the Judicial Branch has prepared and submitted for review and approval its FY**
14 **2018 Bureau of Indian Affairs Judicial Services P.L. 93-638 Budget Amendment No.**
15 **1, which is incorporated by this reference and which will adjust operational**
16 **and/or personnel line items and add new line items; and**

17 **WHEREAS, the FY 2018 Bureau of Indian Affairs Judicial Services P.L. 93-638 Budget**
18 **Amendment No. 1 will increase the Budget by \$130,890.18 from \$482,787.93 to**
19 **\$613,678.11; and**

20 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed the FY 2018**
21 **Bureau of Indian Affairs Judicial Services P.L. 93-638 Budget Amendment No. 1**
22 **and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2018 Bureau of Indian Affairs Judicial Services P.L. 93-638 Budget Amendment**
25 **No. 1, which includes a \$130,890.18 increase from \$482,787.93 to \$613,678.11 that**
26 **shall be funded by FY 2017 P.L. 93-638 carry forward savings.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chief Judge or any**
28 **designated official is authorized to administer and expend the FY 2018 Bureau of**
29 **Indian Affairs Judicial Services P.L. 93-638 Budget as amended, provided that any**
30 **amendments or modifications shall be submitted for prior approval by the**
31 **Tohono O'odham Legislative Council.**
