

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services Division of Community
Health Services Public Health Preparedness Budget Amendment No. 1)

RESOLUTION NO. 18-185

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Health and Human Services ("DHHS") Division of**
8 **Community Health Public Health Emergency Preparedness Budget in the**
9 **amount of \$43,338.00 was approved by Resolution No. 17-381; and**

10 **WHEREAS, the DHHS Division of Community Health Services has prepared and submitted for**
11 **review and approval its FY 2018 Public Health Emergency Preparedness Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will create**
13 **several new operational line items; and**

14 **WHEREAS, the FY 2018 DHHS Division of Community Health Services Public Health**
15 **Emergency Preparedness Budget Amendment No. 1 will increase the FY 2018**
16 **DHHS Division of Community Health Services Public Health Emergency**
17 **Preparedness Budget by \$21,505.10 from \$43,338.00 to \$64,843.10; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2018 DHHS Division of Community Health Services Public Health**
20 **Emergency Preparedness Budget Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2018 Department of Health and Human Services Division of Community Health**
23 **Services Public Health Emergency Preparedness Budget Amendment No. 1**
24 **effective July 1, 2017, which includes a \$21,505.10 increase from \$43,338.00 to**
25 **\$64,843.10 that shall be funded by prior years savings from the Arizona**
26 **Department of Health Services.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2018 Department of Health and Human Services Division of**
30 **Community Health Services Public Health Emergency Preparedness Budget as**
31 **amended, provided however, that any amendments or modifications shall be**
32 **submitted for prior approval by the Tohono O'odham Legislative Council.**


