

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services Division of Health
Transportation Service Budget Amendment No. 1)**

RESOLUTION NO. 18-188

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Department of Health and Human Services ("DHHS") Division of
8 Health Transportation Service Budget was approved by Resolution No. 17-437,
9 which approved funding in the amount of \$2,199,832.00 from the Nation's general
10 fund and Resolution No. 17-442, which approved funding in the amount of
11 \$1,500,000.00 from program revenue, for a combined budget total of
12 \$3,699,832.00; and

13 **WHEREAS,** the DHHS Division of Health Transportation Service has prepared and submitted
14 for review and approval its FY 2018 Budget Amendment No. 1, which is
15 incorporated by this reference and which will adjust salary and operational line
16 items; and

17 **WHEREAS,** the FY 2018 DHHS Division of Health Transportation Service Budget Amendment
18 No. 1 does not change the original budget amount of \$3,699,832.00 and shall be
19 funded by the Nation's general fund; and

20 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
21 reviewed the FY 2018 DHHS Division of Health Transportation Service Budget
22 Amendment No. 1 and recommend its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 **FY 2018 DHHS Division of Health Transportation Service Budget Amendment No.**
25 **1, which does not change the original budget amount of \$3,699,832.00 that shall**
26 **be funded by the Nation's general fund.**

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2018 DHHS Division of Health Transportation Service Budget as**
30 **amended, provided that any amendments or modifications shall be submitted**
31 **for prior approval by the Tohono O'odham Legislative Council.**
