

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Public Safety Fire Department Capital Project
Budget Amendment No. 1)

RESOLUTION NO. 18-192

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Public Safety Fire Department Capital Project Budget**
8 **in the amount of \$2,847,254.66 was approved by Resolution No. 18-008; and**

9 **WHEREAS, the Department of Public Safety Fire Department has prepared and submitted for**
10 **review and approval its FY 2018 Capital Project Budget Amendment No. 1, which**
11 **is incorporated by this reference and which will adjust operational and/or capital**
12 **line items; and**

13 **WHEREAS, the FY 2018 Department of Public Safety Fire Department Capital Project Budget**
14 **Amendment No. 1 does not change the original budget amount of \$2,847,254.66;**
15 **and**

16 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
17 **2018 Department of Public Safety Fire Department Capital Project Budget**
18 **Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2018 Department of Public Safety Fire Department Capital Project Budget**
21 **Amendment No. 1, which does not change the original budget amount of**
22 **\$2,847,254.66 that shall be funded by the Nation's general fund.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2018 Department of Public Safety Fire Department Capital Project**
26 **Budget as amended, provided that any amendments or modifications shall be**
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
29 **day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
