**RESOLUTION NO. 18-193**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only  
6 by a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2018 Chukut Kuk District Budget in the amount of \$1,976,701.13 was  
13 authorized by the Chukut Kuk District Council Resolution No. 2017-48 and  
14 approved by Legislative Council Resolution No. 17-420; and

15 **WHEREAS,** budget amendments for the West Villages Community and Tecolote Community  
16 were authorized by Chukut Kuk District Council Resolutions No. 2018-05, 2018-  
17 06, 2018-12, and 2018-13 and approved by Legislative Council Resolution Nos. 18-  
18 070, 18-091, and 18-092, increasing the FY 2018 Chukut Kuk District Budget to  
19 \$2,090,020.59; and

20 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2018-24 the Chukut Kuk District  
21 has authorized and submitted for review and approval its FY 2018 West Villages  
22 Community Budget Amendment No. 2, which is incorporated by this reference  
23 and which will adjust operational line items; and

24 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2018-27 the Chukut Kuk District  
25 has authorized and submitted for review and approval its FY 2018 Tecolote  
26 Community Budget Amendment No. 3, which is incorporated by this reference  
27 and which will adjust operational line items; and

28 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2018-28 the Chukut Kuk District  
29 has authorized and submitted for review and approval its FY 2018 Chukut Kuk  
30 District Budget Amendment No. 2 which will increase the FY 2018 Budget by  
31 \$51,261.61 from \$2,090,020.59 to \$2,141,282.20, which will adjust operational  
32 and/or personnel line items; and

33 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Chukut Kuk District

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the:**


- (1) FY 2018 West Villages Community Budget Amendment No. 2,**

**which includes a \$51,261.61 increase from \$2,090,020.59 to \$2,141,282.20.**


**BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2018 Chukut Kuk District West Villages Community Budget, the FY 2018 Chukut Kuk District Tecolote Community Budget and the FY 2018 Chukut Kuk District Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 2,969.05 FOR; 115.55 AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
