

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Hewel Ni'ok Administration Budget Amendment No. 1)

RESOLUTION NO. 18-200

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, by Resolution No. 17-437, the Legislative Council approved the FY 2018 Hewel**
8 **Ni'ok Administration Budget in the amount of \$564,461.77 as a part of the**
9 **Executive Branch budget; and**

10 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2018**
11 **Hewel Ni'ok Administration Budget Amendment No. 1 in the amount of**
12 **\$564,461.77, which is incorporated by this reference and which will adjust**
13 **operational and/or personnel line items but does not change the original budget**
14 **amount; and**

15 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have reviewed**
16 **the FY 2018 Hewel Ni'ok Administration Budget Amendment No. 1 and**
17 **recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2018 Hewel Ni'ok Administration Budget Amendment No. 1 effective October 1,**
20 **2017 in the amount of \$564,461.77, which does not change the original budget**
21 **amount.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2018 Hewel Ni'ok Administration Budget as amended, provided**
25 **that any amendments or modifications shall be submitted for prior approval by**
26 **the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
28 **day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
