

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Education Higher Education Services
Budget Amendment No. 1)

RESOLUTION NO. 18-204

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Education Higher Education Services Budget in**
8 **amount of \$790,092.87 was approved by Resolution No. 17-438; and**

9 **WHEREAS, the Tohono O'odham Nation's Grants and Contracts Office has identified FY 2017**
10 **carry forward savings in the amount of \$361,105.87 for the Higher Education**
11 **Services Budget, of which \$34,485.77 shall be utilized in FY 2018 and \$326,620.10**
12 **shall be utilized in FY 2019; and**

13 **WHEREAS, the Department of Education has prepared and submitted for review and**
14 **approval its FY 2018 Higher Education Services Budget Amendment No. 1, which**
15 **is incorporated by this reference and which will adjust personnel and/or**
16 **operational line items; and**

17 **WHEREAS, the FY 2018 Department of Education Higher Education Services Budget**
18 **Amendment No. 1 will increase the FY 2018 Higher Education Services Budget by**
19 **\$34,485.77 from \$790,092.87 to \$824,578.64; and**

20 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
21 **reviewed the FY 2018 Department of Education Higher Education Services Budget**
22 **Amendment No. 1 and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2018 Department of Education Higher Education Services Budget Amendment**
25 **No. 1 effective October 1, 2017, which includes a \$34,485.77 increase from**
26 **\$790,092.87 to \$824,578.64 that shall be funded by the Nation's general fund**
27 **pending reimbursement from the grantor.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
29 **Nation chairperson or any designated official is authorized to administer and**
30 **expend the FY 2018 Department of Education Higher Education Services Budget**
31 **as amended, provided however, that any amendments or modifications shall be**
32 **submitted for prior approval by the Tohono O'odham Legislative Council.**

7 18, 1934 (48 Stat.984).
