

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Gaming Office Budget Amendment No. 1)**

**RESOLUTION NO. 18-211**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, by Resolution No. 17-437 the Legislative Council approved the FY 2018 Gaming**  
8 **Office Budget in the amount of \$7,639,801.29; and**

9 **WHEREAS, the Gaming Office has prepared and submitted for review and approval its FY**  
10 **2018 Gaming Office Budget Amendment No. 1, which is incorporated by this**  
11 **reference and which will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2018 Gaming Office Budget Amendment No. 1 will not increase the Gaming**  
13 **Office FY 2018 Budget amount of \$7,639,801.29; and**

14 **WHEREAS, the Commerce and Budget and Finance Committees have reviewed the FY 2018**  
15 **Gaming Office Budget Amendment No. 1 and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2018 Gaming Office Budget Amendment No. 1, effective October 1, 2017, which**  
18 **will not increase the budget amount of \$7,639,801.29 that shall be funded by the**  
19 **Nation's general fund.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
21 **Nation chairperson or any designated official is authorized to administer and**  
22 **expend the FY 2018 Gaming Office Budget as amended, provided that any**  
23 **amendments or modifications shall be submitted for prior approval by the**  
24 **Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
26 **day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 2,853.5 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and 231.1 [03] ABSENT, pursuant to the powers vested in the Council**  
28 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
31 **Act of June 18, 1934 (48 Stat.984).**
