

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Baboquivari District – Fresnal Canyon Community
Budget Amendment No. 1)

RESOLUTION NO. 18-216

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the districts council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2018 Baboquivari District Budgets were approved by Tohono O'odham
13 Legislative Council Resolution No. 17-419 in the amount of \$3,255,026.67; and

14 **WHEREAS,** by Baboquivari District Council Resolution No. 2018-B-43, the Baboquivari
15 District has authorized and submitted for review and approval its FY 2018
16 Baboquivari District – Fresnal Canyon Community Budget Amendment No. 1,
17 which is incorporated by this reference and which will adjust operational and/or
18 personnel line items; and

19 **WHEREAS,** the FY 2018 Baboquivari District – Fresnal Canyon Community Budget
20 Amendment No. 1 will not change the Fresnal Canyon Community Budget amount
21 of \$355,233.10 nor the overall Baboquivari District Budget amount of
22 \$3,255,026.67; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Baboquivari District
24 – Fresnal Canyon Community Budget Amendment No. 1 and recommends its
25 approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 FY 2018 Baboquivari District – Fresnal Canyon Community Budget Amendment
28 No. 1, which does not change the Fresnal Canyon Community Budget amount of
29 \$355,233.10, nor the overall Baboquivari District Budget amount of \$3,255,026.67.

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2018
31 Baboquivari District – Fresnal Canyon Community Budget as amended shall be
32 managed and expended in accordance with Article IX, Section 7 of the
33 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that
34 any amendments or modifications shall be authorized under District Council

resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14th day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 2,853.5 FOR; -0- AGAINST; -0- NOT VOTING; and 231.1 [06] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
