

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2018 First Things First Budget Amendment No. 1)**

**RESOLUTION NO. 18-218**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Education First Things First Budget in the amount of**  
8 **\$50,000.00 was approved by Resolution No. 17-335; and**

9 **WHEREAS, the Department of Education has prepared and submitted for review and**  
10 **approval its FY 2018 First Things First Budget Amendment No. 1, which is**  
11 **incorporated by this reference and which will adjust operational line items and**  
12 **will create a new line item; and**

13 **WHEREAS, the FY 2018 Department of Education First Things First Budget Amendment No. 1**  
14 **will not change the overall budgeted amount of \$50,000.00; and**

15 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
16 **reviewed the FY 2018 Department of Education First Things First Budget**  
17 **Amendment No. 1 and recommend its approval.**


18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2018 Department of Education First Things First Budget Amendment No. 1,**  
20 **which will not change the overall budgeted amount of \$50,000.00.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2018 Department of Education First Things First Budget as**  
24 **amended, provided that any amendments or modifications shall be submitted**  
25 **for prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup>**  
27 **day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 2,813.7 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and 270.9 [07] ABSENT, pursuant to the powers vested in the Council**  
29 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
30 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
31 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
32 **Act of June 18, 1934 (48 Stat.984).**


