

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Certification of A Tohono O'odham Nation Eligible Adult Member
for the Third Per Capita Distribution for July 2018)**

RESOLUTION NO. 18-226

- 1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**
2 **"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes**
3 **per capita payments to the Nation's members provided that sufficient gaming**
4 **revenues are available; and**
- 5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities Within the Tohono**
6 **O'odham Nation (the "Gaming Ordinance") was subsequently amended to**
7 **authorize per capita distribution payments in accordance with the Initiative**
8 **(Legislative Council Resolution No. 97-303); and**
- 9 **WHEREAS, the Legislative Council did adopt the Third Revenue Allocation Plan pursuant to**
10 **Legislative Council Resolution No. 06-307; and**
- 11 **WHEREAS, on July 28, 2006, the Secretary of the Department of Interior approved the Third**
12 **Revenue Allocation Plan; and**
- 13 **WHEREAS, the Tohono O'odham Nation Department of Membership Services submitted to**
14 **the Tohono O'odham Legislative Council the Master List for Eligible Adult Tohono**
15 **O'odham Members for the Third Per Capita Distribution ("Master List") for review**
16 **and approval; and**
- 17 **WHEREAS, Legislative Council approved the Master List with the initial number of 17,669**
18 **verified adult members (Resolution Number 06-624); and**
- 19 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**
20 **verification of a member and certification by the Tohono O'odham Legislative**
21 **Council; and**
- 22 **WHEREAS, the Tohono O'odham Department of Membership Services has submitted a**
23 **certification list of one verified adult member who is listed on the previously**
24 **approved Master List and is eligible to receive the third per capita payment.**
- 25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**
- 26 **1. Approves the verification and certification of the adult member listed on the**
27 **attached July 2018 Certification Listing of an Adult Member for the Third Per**
28 **Capita Distribution.**
- 29 **2. Approves the distribution of \$2,000, less any applicable taxes required by**
30 **federal law, to the adult member listed.**
- 31 **3. Authorizes the Chairperson of the Nation or a designated official to execute**
32 **such other documents as may be necessary to implement this resolution.**

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of funds to additional eligible Tohono O'odham adult members is contingent upon verification of membership by the Tohono O'odham Department of Membership Services and certification by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH day of JULY, 2018 at a meeting at which a quorum was present with a vote of 2,991.75 FOR; 92.85 AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Sections 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
