

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Education One Stop Division PY18/FY19 Budgets)**

RESOLUTION NO. 18-230

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Arizona Department of Economic Security Workforce Innovation and**
8 **Opportunity Act ("WIOA") Title 1B, Intergovernmental Agreement ("IGA") was**
9 **approved by Resolution No. 15-441; and**

10 **WHEREAS, the Arizona Department of Economic Security has granted the Tohono O'odham**
11 **Nation One Stop Division \$376,542.99 for a period beginning on July 1, 2018**
12 **through June 30, 2019; and**

13 **WHEREAS, the Department of Education has prepared and submitted for review and**
14 **approval its FY 2019 One Stop Division PY18/FY19 Budgets, which are**
15 **incorporated by this reference, in the total amount of \$376,542.99:**

PY18 Youth	\$200,625.00
FY19 Adult Admin	\$3,252.99

23 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
24 **reviewed the FY 2019 Department of Education One Stop Division PY18/FY19**
25 **Budgets and recommend their approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
27 **FY 2019 Department of Education One Stop Division PY18/FY19 Budgets in the**
28 **amount of \$376,542.99 effective July 1, 2018, which shall be funded by the Nation's**
29 **general fund pending reimbursement from the State of Arizona's Department of**
30 **Economic Security.**

31 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
32 **Nation chairperson or any designated official is authorized to administer and**
33 **expend the FY 2019 Department of Education One Stop Division PY18/FY19**

Budgets, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH day of JULY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Sections 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


