

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 General Support Services, Accounting Office Capital Project Budget)

RESOLUTION NO. 18-232

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Accounting Office has recognized the need to improve functionality of the**
8 **workplace to ensure the safety and security of personnel within the Accounting**
9 **Office; and**

10 **WHEREAS, to meet this need, installation of modular workstations and renovations of the**
11 **general work area are necessary; and**

12 **WHEREAS, the General Support Services ("GSS"), Accounting Office has prepared and**
13 **submitted for review and approval its FY 2018 Accounting Office Capital Project**
14 **Budget, which is incorporated by this reference, in the amount of \$160,000.00 to**
15 **be funded by the Nation's general fund surplus; and**

16 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2018 GSS, Accounting**
17 **Office Capital Budget and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2018 GSS, Accounting Office Capital Budget, in the amount of \$160,000.00 that**
20 **shall be funded by the Nation's general fund surplus.**

21 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that any funds not**
22 **expended in FY 2018 may be carried forward and expended in FY 2019 if needed.**


23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2018 GSS, Accounting Office Capital Budget, provided that any**
26 **amendments or modifications shall be submitted for prior approval by the**
27 **Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
29 **day of JULY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**




