

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Sells District Mining Royalties Budgets)**

**RESOLUTION NO. 18-233**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only**  
6 **by a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS, by Sells District Council Resolution No. SD-53-18, the Sells District has authorized**  
13 **and submitted for review and approval the FY 2018 Sells District Mining Royalties**  
14 **Budgets, which are incorporated by this reference, in the total amount of**  
15 **\$111,948.13; and**

16 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2018 Sells District Mining**  
17 **Royalties Budgets and recommend approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2018 Sells District Mining Royalties Budgets in the total amount of \$111,948.13.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2018 Sells**  
21 **District Mining Royalties Budgets shall be managed and expended in accordance**  
22 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**  
23 **the Nation's laws, provided that any amendments or modifications shall be**  
24 **authorized under District Council resolution and submitted for prior approval by**  
25 **the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>**  
27 **day of JULY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
32 **(48 Stat.984).**
